4. First-aid Measures**4.1 Description of First Aid Measures****GENERAL NOTES:** Show this safety data sheet to the doctor in attendance.**AFTER INHALATION:** Move to fresh air. Provide fresh air, rest and warmth. Call a physician immediately. Give oxygen or artificial respiration if needed. When risk of unconsciousness, place and transport the victim in secured recovery position.**AFTER SKIN CONTACT:** Use a mild soap if available. Heating or fire conditions liberates toxic gas.
